## **Sub 590 Student Check List**

Check	Personal Documents
	The pages of each applicant's current passport showing photo, personal details and passport issue and expiry dates
	Proof of their relationship to each family members such as official birth certificate or marriage certificate Family book or Family registration Certificate in English
	Two recent passport photographs (45 mm x 35 mm):
	a birth certificate showing the names of both parents
	Certified copy of evidence of the name change (if applicable)
Check	Dependants Documents
	Certified copies of marriage certificates or relationship registrations
	If you are in a de facto relationship: evidence that you have been in the relationship for at least 12 months
	Birth Certificates of any dependants under 18 years of age
	For dependants who are 5 to 17 years old and joining you: evidence of enrolment in an Australian school, including payment of any required fee
Check	Qualification
	The e CoE certificate(s) for the course(s) you are undertaking
	Highest qualification in your home country (Graduation Certificate & Transcript)
	All qualification in Australia (Graduation Certificate & Transcript)
	Certificate from a specified English language test showing that you meet the English language skill requirement
Check	Health Requirements
	Evidence that you have OVHC for the duration of your visa, covering you and your dependants OR another health insurance product from Australia or your home country that provides a similar level of cover.
	You may be required to undergo medical examination
Check	Financial Documents
	Where you need to provide evidence of financial capacity, you will be able to demonstrate this by providing one of the following:
	Minimum 12-months' living cost for your stay in Australia
	evidence of funds to cover travel costs and 12 months' living costs for yourself and any other children coming with you
	evidence that your spouse (who is not travelling to Australia) will support you and your dependants and has an annual income of at least AUD 70,000.
	a) money deposits with a financial institution b) financial institution or government loans

	c) scholarships or sponsorships
	When we assess your application, we decide whether the funds shown will be genuinely available by taking into account factors, such as:
	<ul> <li>a) the nature of the relationship between you and the person providing the funds, where applicable</li> <li>b) your income, assets and employment or that of the person who is providing the funds</li> <li>c) your previous visa history and that of the person providing the funds.</li> </ul>
	Sponsor's Affidavit of support, identification and proof of relationship
	The annual income requirement is AUD 70,000 or more. The income must be one of the following:

Check	Additional recommended documents
	Resume showing entire work & education history with the from/to dates since high school graduation and Employment letter
